other business or office address of the Applicants, including removal and refraining from using any address of the Applicants in and from all of the Respondent's marketing, promotional, and advertising material in any form whatsoever, including any electronic media such as websites including the website at [www.vp-markets.net](http://www.vp-markets.net), emails, social media postings, and including any and all print media such as newspapers, magazines, letterheads, business cards, and flyers;


4. **THIS COURT ORDERS AND ADJUDGES** that the Respondent, Asia Pacific Futures Investment Limited and its directors, servants or agents shall immediately remove, delete and refrain from using the Applicant business address at 1123 Leslie Street, North York, ON M3C 2K5, Canada, or any other business or office address of the Applicants, including removal and refraining from using any address of the Applicants in and from all of the Respondent's marketing, promotional, and advertising material in any form whatsoever, including any electronic media such as websites including the website at [www.ytqmt.com](http://www.ytqmt.com), emails, social media postings, and including any and all print media such as newspapers, magazines, letterheads, business cards, and flyers;

5. **THIS COURT ORDERS AND ADJUDGES** that the Respondents, VP Markets Global Ltd. and Asia Pacific Futures Investment Limited, shall, jointly and severally, pay to the Applicants, the costs of the within application fixed in the amount of \$14,325.75 which are payable within 30 days.

6. **THIS JUDGMENT BEARS INTEREST** at the rate of two (2) percent per year commencing on June 22, 2021.

7. **THIS COURT ORDERS AND ADJUDGES** that a copy of this Judgment shall be served upon the Respondents forthwith by email and letter mail at the respective addresses in paragraph 1 hereinabove.

8. **THIS COURT ORDERS AND ADJUDGES** that this Judgment in a scanned and electronic form is operative, enforceable, and binding from its date of signing without the need to be issued and entered (despite Rule 59.05).
